<u>Event To-Go Suggested Retail Prices</u>: Are per person, unless otherwise specified, tax inclusive. Excise tax is 4.712%. Prices, contents and line-up of artists subject to change.

Event To-Go Enhancements: Add to perfect your event. Full list available online.

Special Arrangement with 72 Hours Notice: Refer to SP-GI.

<u>Catering To-Go</u>: Additional charge applies for delivery/distance in areas beyond the city of Honolulu and for permission fees at some locations. Client responsible for securing location and providing/setting up tent, buffet tables, individual tables, chairs and linen.

<u>Entertainment To-Go</u>: Includes sound check/rehearsal conducted by our production manager/ sound operator, who will stay throughout the performance. All cast members to be on site for rehearsal/check. Clients responsible for stage, lighting and sound system, dressing room, parking fee, travel expenses. <u>Track Show Rider</u>: Ask for "Track Show Rider" contract for details and client's responsibility.

Parking: Shall be provided by the Charterer

Closed Days: Closed on New Year's Day (1/1/24), Independence Day (7/4/24), Honolulu Marathon (12/8/24), Christmas Day (12/25/24) and New Year's Eve (12/31/24).

<u>Damage / Protection</u>: We retain the right to refuse any event, or to require Booking Party to pay for security, additional fees, deposits, or any damage to our property.

## **Quote / Booking / Confirmation / Cancellation**

All Deposits / Payments are non-refundable and based on estimated final or minimum count, and are in effect at the time of booking. Non-payment subjects your reservation to cancellation.
