Stage, Lights & Sound Equipment

1. **Stage:** Stage size of 16' (4.87m) x 24' (7.32m) or larger for a cast size of 12 members and up.
 - A raised stage is recommended for groups over 200 guests.
 - A hard floor stage may be required for some performances. **Required for MJ performance.**
2. **Lighting System with Operator:**
 - House Lighting **OR** Special Lighting for Elvis & MJ / Artist from Las Vegas (see below A, B & C).
 - A) 3 Color Wash (red, blue, amber) to illuminate the entire stage; B) 3 Backlight Specials (white, red, blue) focused on artist's mic down-stage-center, or on fire knife dancer; C) Plus, 1 Follow Spot with second operator.
3. **House Sound System** capable of reproducing undistorted and evenly distributed sound at 105db (recommended frequency response from 40Hz) throughout the seating area.
 - Includes: (1 or 2) wireless microphone(s), and additional long-corded wired microphones if needed.
 - System is equipped with 1/3 octave equalization for all sends and must include both digital reverb and delay.
 - Monitor system includes (2) separate mixes, (5) wedge monitors, and (2) side fills (monitors must carry digital reverb and delay in the mix).
 - System includes capability to play music tracks from USB flash drive, iPhone, iPod or iPad.
4. **Power:**
 - (2-8) 20-amp circuits dedicated to stage and spotlight.

Dressing Room

- Separate Female / Male Dressing Rooms** or one room separated in half for privacy must be provided.
- Private Dressing Room(s)** shall be located near the stage and include hanging racks, mirror, table, lighting, towels and a water station (or bottled water) for entertainers.

Additional Notes

- For outdoor events** weather proof shelters shall be provided.
- Sound Check / Rehearsal** 2 hours prior to performance is included. [Contact Becky Newbold at 497-0151 to setup one week prior.](#)
- For Fire Knife Dance Performance:** The performer must be 20' (6.09m) away from audience and 25' (7.62m) from anything combustible. Fire extinguisher must be within 30' (9.14m) of performer.
- For Fire Knife Dance / Artist Performance:** Audience must remain seated and no food / beverage shall be served during the performance.
- Expenses on Oahu:** Client shall pay all parking fees for all cast members.
- Traveling Expenses** outside of Oahu including airfare, hotel accommodations, transportation from airport to hotel / venue and reverse, meals, insurance. An event agreement will be written for each event.
- Confirmation / Payment / Cancellation Terms (Oahu):** Events require a non-refundable deposit based on total charge. 10% deposit upon confirmation, 40% 30 days prior, and balance of 50% 72 hours prior. Price and content subject to change. **Full payment due by [Date]**
